



Touching Lives

#### ADULTS AND CHILDREN WITH LEARNING AND DEVELOPMENTAL DISABILITIES

The ACLD Bethpage Zen Room is a specially designed sensory room, which contains a range of stimuli to help individuals with autism, learning, and other developmental disabilities, to develop and engage their senses. The Zen Room will be in Bethpage at the ACLD Adult Day Program, which provides support to more than 130 people. Individuals learn to interact with the world around them by using the Zen Room in a safe environment that builds their confidence and ability.

#### **BIG BROTHERS/BIG SISTERS OF LONG ISLAND**

The Big Brothers/Big Sisters Long Island Match Enrichment Activities Program is an ongoing, essential component of the Big Brothers Big Sisters community, and is used to facilitate important bonding experiences for Matches, which lead to more enduring and rewarding Big/Little relationships.

#### THE BOOK FAIRIES

Nassau County Literacy Programs New York has one of the highest illiteracy rates in the nation, and there is a tremendous inequity in access to books. The Book Fairies' work shifts resources that already exist from those who no longer need them to those who do, through programs that engage directly with Nassau County schools and organizations to meet the needs of constituents.

#### **CAMP HORSEABILITY**

The Camp HorseAbility Equine Assisted School Groups provides mental health support, life skills development, wellness, and socialization skills to local students with special needs.

#### CHRISTMAS DREAM

Christmas Dream provides underprivileged children and their families with items that stabilize their environments, such as home heating, food, clothing, and language skills. Recently, the program provided backpacks and school supplies for 275 children, underwear for 2000 students, snacks for 600 to be delivered to schools, toothbrushes for 250 children that didn't have or were using a "family toothbrush", rented a bus to transport children to receive free clothing for school, and hired teaching aides for their language center.

#### DANCE PARTY FOR PARKINSON'S, INC.

Dance Party for Parkinson's allows people with Parkinson's disease and their caregivers to attend virtual movement classes free of charge. In 2023, Dance Party for Parkinson's held their first in-person fundraiser since the pandemic, "Rock Your Body for Parkinson's", a cabaret-style show that allowed them to continue to raise money for research.

#### GIRL SCOUTS OF NASSAU COUNTY

Girl Scouts Where You Live brings Girl Scouting to girls who live in public housing, homeless shelters, communities with large numbers of non-English speaking residents, families with insecure living arrangements, and with financial difficulties. Programming is designed to strengthen a girl's sense of herself and boost her capacity to seek and meet challenges in her world.

#### **HICKSVILLE BOYS & GIRLS CLUB**

The Hicksville Boys & Girls Club runs an after-school program called the Drop In Lounge Program, which is designed to put normalcy back into the lives of the children and support those in need through recreational, educational, and referral services programs.

#### THE INN (INTERFAITH NUTRITION NETWORK)

The INN's Long Term Housing Program is a comprehensive model which offers formerly homeless families and veterans a fully furnished apartment with utilities included at a significantly reduced fair market rate.

#### **ISLAND HARVEST**

The Island Harvest Food Collection & Distribution Program purchases and collects donated food and products to distribute to over 400 registered food pantries, soup kitchens, shelters, day cares, senior centers, and other nonprofit organizations with feeding programs throughout both Nassau and Suffolk Counties.

#### LONG BEACH REACH

The Harriet Eisman Community School will offer intense out-patient treatment services three trimesters a year typically offering 24 courses to approximately 75 students. Long Beach Reach's goal is to help sustain and enhance their school program which has suffered a severe reduction of funding due to the Nassau County fiscal crisis.

#### LONG ISLAND ALZHEIMER'S AND DEMENTIA CENTER

LIAD Center's Legal Services and Information for Those Caring for Adults with Down Syndrome & Alzheimer's Disease Programs benefit adults and the people who love and support them by expanding their referral network of attorneys and legal service providers to include specialists in disability law to help patients and families.

#### LONG ISLAND COUNCIL OF CHURCHES

The Long Island Council of Churches Emergency Food and Family Support Services supports hunger alleviation and family support programs for low to moderate income populations in Nassau County.

#### LONG ISLAND CRISIS CENTER

The Long Island Crisis Center provides workshops on-site in schools formatted for both students and professional staff, responding to emerging health problems and emotional dilemmas that are threating young people and representing challenging behaviors for classroom teachers to resolve in an academic setting. The Long Island Crisis Center is currently focused on issues including suicide prevention, anger management, cyber bullying, understanding self-injury, homophobia, transphobia, and facilitating gay/straight alliances.

#### LONG ISLAND SLED HOCKEY, INC.

Long Island Sled Hockey, Inc. is unique in its concept of enjoining both the physical and mentally challenged athletes together in the same venue. In addition to never turning a "differently-abled" person away from the program, Long Island Sled Hockey athletes pay nothing—ever—to participate, nor do they pay for tournament travel, air travel, bus travel, hotels, meals, or sled hockey equipment.

#### MAURER FOUNDATION FOR BREAST HEALTH EDUCATION

The Maurer Foundation promotes breast health awareness to high school students in Nassau County through their live webinar-based health programs. Each program is the length of one school period.

#### MINEOLA HIGH SCHOOL STUDENT SERVICE CENTER

The Mineola High School Student Service Center has a "Lunch Bunch" program where senior citizens from the community meet with high school students to have lunch with one another. After lunch, the group participates in programming and activities.

#### MOMMA'S HOUSE

The MOMMAS House Transitional Housing Program works with young mothers and their children by providing shelter, support, advocacy, instruction, and love for up to two years the young mothers and children may live there. The program addresses homelessness, offers a stable environment to encourage mothers to obtain training and schooling, and creates strong families by assisting the women with independent living skills.

#### NASSAU BAR FOUNDATION (LAP)

The Nassau Bar Association Lawyer Assistance Program (NCBA LAP) provides confidential assistance to attorneys, judges, and law school students—and their immediate families—who are struggling with alcohol, drug and/or mental health problems, gambling, eating disorders, or are affected by the problem of substance abuse, stress, or depression. The program also assists attorneys and their families in situations where a practice will close due to illness, death, disability or disbarment, and attempt to arrange for the legal work of client cases where necessary.

#### NASSAU CEREBRAL PALSY GUARDIANSHIP CORPORATION

The Nassau Cerebral Palsy Guardianship Corporation provides vital services to those who do not have the financial resources to pay for these services otherwise.

#### NASSAU SUFFOLK AUTISM SOCIETY OF AMERICA

Nassau Suffolk Autism Society of America ("NSASA") is a parent-run organization serving over 5,000 families on Long Island. NSASA has a Swimming Safety program which grant people with autism and their families the opportunity to participate in an open swim program. This program includes water safety education, swimming lessons, and aquatic activities.

#### NORTH SHORE CHILD AND FAMILY GUIDANCE

The Children's Center at Nassau County Family Court offers short-term childcare to families who must appear in Family Court at no cost. The program provides the children with a safe and supervised environment to play and learn while their parents or guardians attend court.

#### PORT WASHINGTON PARENT RESOURCE CENTER

The Port Washington Parent Resource Center's primary purpose is to provide support for parents and children of all income levels. The Resource Center also runs the Outreach Program for families who are new to the country and/or who are low income, which includes Thursday morning Stepping Stone class, scholarships for the general programming of the Resource Center and summer camp, ESL classes for adults, and Summer field trips.

#### PORT WASHINGTON SENIOR CITIZENS, INC.

The Port Washington Senior Citizens Lunch Program provides hot meals for the members of the organization. These lunches are the seniors' main meal of the day, and usually the only hot meal they eat in a day.

#### ROTACARE

RotaCare provides free primary care and medications to their patients; most of their patients have Diabetes. A patient diagnosed with Diabetes automatically requires at least four different medications, of which Insulin is the most critical. Funds raised for this program go towards purchasing and providing Insulin for patients who need and cannot afford it.

#### SAFE CENTER OF LONG ISLAND

The Safe Center of Long Island's Language Line Project helps provide timely and appropriate language translation services to domestic violence, child abuse, sexual assault and human trafficking victims in Nassau County who do not speak English or are of limited English proficiency.

#### THE SARAH GRACE FOUNDATION FOR CHILDREN WITH CANCER, INC.

The Sarah Grace Foundation's Gabe's Chemo Duck Project provides chemo duck to children going through cancer treatment. A chemo duck is a stuffed toy duck that is available with different kinds of 'ports' that are used to dispense chemo and other medications. Each child newly diagnosed with cancer receives their own personal duck and the hospital staff uses the duck to educate the child about the treatment they are about to receive and how to care for their port. This teaching tool helps ease the anxiety of the children during this stressful time.

#### SCOTT J. BEIGEL MEMORIAL FUND

The Scott J. Beigel Memorial Fund supports organizations to send at-risk youth, economically disadvantaged and underserved children, ethnic, and racial groups to sleep-away camps.

#### SIBSPLACE

SIBSPlace Tween/Teen Programming develops and provides prevention-based services specifically designed to meet the needs of children ages 12-17 years old. They will meet once a month on Friday evenings to provide a safe social outlet, where they can build peer relationships and address more advanced teen-centered topics.

#### THEODORE ROOSEVELT COUNCIL, INC. BOY SCOUTS OF AMERICA





#### CHILDREN'S FESITVAL
